2. Organization

The Maghreb Virtual Area Control Center (hereafter referred as MAGvACC) is a part of VATMENA, and in turn VATSIM. The aim is to provide and facilitate the controlling of the simulated online environment within the Kingdom of Morocco, Algeria and Tunis with an exceptional degree of realism. MAGvACC is responsible for the training of Virtual Air Traffic Controllers and the staffing of ATC positions, along with the safe operation of the virtual airspace designated as CASABLANCA Flight Information Region (GMMM FIR), AGADIR Flight Information Region (GMAC FIR), ALGIERS Flight Information Region (DAAA FIR) and TUNIS Flight Information Region (DTTC FIR). The rules and regulations as determined by VATSIM are included within the Code of Conduct and Code of Regulations and apply to ALL MAGvACC Members.



3. General Provisions

3.1 Applicability

This document describes Maghreb vACC policies and procedures on the collection, use and disclosure of information & data via the VATSIM Connect Service to deliver services to users of the Maghreb vACC website. This policy explains what data is collected, how it is collected, how it is used, and how a user can manage his or her data. This policy aims to comply with the General Data Protection Regulations of the European Union and applies to all users of Maghreb vACC website, regardless of whether they are residents of the Kingdom of Maghreb or not.

3.2 Changes

This Policy is subject to change at short notice with immediate effect at any time. vACC Staff & members shall ensure they always remain up to date with the latest policy and procedure changes by the VATSIM Code of Conduct and Code of Regulations; all members are expected to abide and comply with the rules and regulations as set out in these documents. By using any MAGvACC service or facility, all members agree to the rules set forward by VATSIM CoC and CoR. A member's right to staff any ATC position in the Maghreb Airspace is subject to the VATSIM Global Rating Policy (GRP2) and the local rules of VATMENA and MAGvACC. A member violating rules and regulations of MAGvACC may be suspended from using facilities such as Discord server based on the decision of a committee formed by MAGvACC Staff.



4. Data Collection

4.1 Types of Data

VATSIM collects a variety of personal information from members both when they register and while they are connected to the VATSIM network. Through VATSIM Connect Service, Maghreb vACC may collect data that includes:

- VATSIM Certificate ID
- VATSIM CERT Full Name
- VATSIM CERT Email Address
- VATSIM CERT ATC Rating, Pilot Rating
- VATSIM CERT Region, Division, Sub-division
- Discord User ID, Profile Picture

Maghreb vACC does not collect any password, access tokens or any sensitive data.

4.2 Why collecting the data

VATSIM asserts that it has a legitimate interest in collecting and storing the personal data outlined above. The reasons for this claim are:

- VATSIM and Maghreb vACC are a voluntary community promoting flight simulations and virtual air traffic control, and all members seeking to join have an obvious interest in such activities.
- The data collected is the minimum required to generate a member's profile in our database & Discord and allow for the smooth and optimal running of the network, solely for the enjoyment of its members.
- The data is necessary to allow for the expected interactions between simulated pilots and air traffic controllers on the network to take place.
- The data is necessary to allow for VATSIM and Maghreb vACC staff to properly manage the network, both in day-to-day operations, and in circumstances where a member(s) may act in a manner contrary to the VATSIM User Agreement, Code of Regulations and/or Code of Conduct.



5. Permissions

5.1 Permission to store the data

By logging into Maghreb vACC website using the VATSIM Connect Service:

- You automatically agree to the terms of this Data Handling Policy, and consent to the use of your data in the ways described in this document. If at any time you no longer consent to the use of your data in any of the ways described in this document, then you may request to have your account and all associated data removed from our servers.
- You automatically consent to the use of your Discord data in the methods stated in this document by integrating your Discord account through Discord OAuth. If you no longer agree to the use of your Discord data in any of the ways specified in this document, you can unlink your Discord account from your dashboard at any time. This action will delete the Discord data linked with your account from our servers automatically.

5.2 Access to the data

Only Maghreb vACC staff has access to your data and doesn't share or offer it voluntary.

5.3 Removal of personal data

You have the right to request that all or part of your data be removed from our system. To do so, send an email to management@vatsim.ma, using your VATSIM email address. We have up to 30 days to comply under GDPR. Your data will be deleted and you will receive an email confirmation.

5.4 Links to Other websites

Maghreb vACC's website may contain links to other websites. If you click on a third-party link, you will be directed to that website. We strongly advise you to review the Privacy Policy of these websites as they are not operated by us. Maghreb vACC assumes no responsibility for the content, privacy policies, or practices of any third-party websites or services.



6. Children Privacy

Maghreb vACC entrusts VATSIM to only accept members above the legal age of consent for data processing. Where there is reasonable doubt that legitimate consent has been received, members will have access to Maghreb vACC's services restricted until clarity is sought by VATSIM Membership Department.
